WHEREAS, a procedure has been developed to help implement the Enhanced 911 Street Naming and Addressing project; and

WHEREAS, naming unnamed rights-of-way will assist 911 Emergency Services to more quickly and efficiently locate 911 callers, thereby avoiding delays in providing necessary emergency services; and

WHEREAS, on December 11, 2006 public hearings were held by the Kenai Peninsula Borough Planning Commission to address all concerns about the proposed street name changes; and

WHEREAS, Chapter 14.10 of the Kenai Peninsula Borough Code of Ordinances authorizes the Planning Commission to accomplish street name changes by Resolution.
