RESOLUTION SN 2009-02

**RENAMING A CERTAIN PUBLIC ROADWAY EASEMENT WITHIN SECTIONS 34, T5N R11W;
WITHIN EMERGENCY SERVICE NUMBER (ESN) 302**

WHEREAS, a procedure has been developed to help implement the Enhanced 9-1-1 Street Naming and Addressing project; and

WHEREAS, eliminating duplicate and sound-alike street names will enable 9-1-1 Emergency Services to respond to emergencies in an efficient timely manner, thereby avoiding delays in providing necessary emergency services; and

WHEREAS, on January 26, 2009 public hearings were held by the Kenai Peninsula Borough Planning Commission to address all concerns about the proposed street name changes; and

WHEREAS, Chapter 14.10 of the Kenai Peninsula Borough Code of Ordinances authorizes the Planning Commission to accomplish street name changes by Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE KENAI PENINSULA BOROUGH:

Section 1. That the roadway easement listed below is renamed as follows:

DESCRIPTION	FROM	TO	BASE MAP
a. UNNAMED 30' PUBLIC ROADWAY EASEMENT originally recorded as Book 123 Page 527 KRD; recently recorded within Zephyr Field Estates Part 5 (KN2006-52), Zephyr Field Estates Condominiums – Phase 3 Units 35 through 50 (KN2008-24) and Zephyr Field Estates Condominiums – Phase 4 Units 51 through 72 (KN2008-102) which is partially within an unsubdivided remainder of Zephyr Field Estates Subdivisions Part 1 thru 6. T5N R 11W SECTION 34 Seward Meridian; off of Jones Road in the Kalifornsky Community; ESN 302	UNNAMED RD	MISTRAL ST	KR19

Section 2. That according to Kenai Peninsula Borough Code of Ordinance 14.10.030, the official street name map, 1:500 scale base maps Kenai River 19 is hereby amended to reflect these changes.

Section 3. That the map showing the location of the renamed rights-of-way be attached to, and made a permanent part of this resolution.

Section 4. That this Resolution takes effect immediately upon adoption.

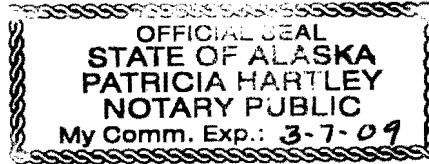
