

**KENAI PENINSULA BOROUGH
PLANNING COMMISSION RESOLUTION**

RESOLUTION SN 2009-10

NAMING CERTAIN PUBLIC ROADWAY EASEMENTS WITHIN SECTION 23, T6N R12W;
WITHIN EMERGENCY SERVICE NUMBER (ESN) 501

WHEREAS, a procedure has been developed to help implement the Enhanced 9-1-1 Street Naming and Addressing project; and

WHEREAS, eliminating duplicate and sound-alike street names will enable 9-1-1 Emergency Services to respond to emergencies in an efficient timely manner, thereby avoiding delays in providing necessary emergency services; and

WHEREAS, on June 22, 2009 public hearings were held by the Kenai Peninsula Borough Planning Commission to address all concerns about the proposed street name changes; and

WHEREAS, Chapter 14.10 of the Kenai Peninsula Borough Code of Ordinances authorizes the Planning Commission to accomplish street name changes by Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE KENAI PENINSULA BOROUGH:

Section 1. That the roadway easement listed below is renamed as follows:

b.	Unnamed BLM 66' Reservation Easement lying between Gov lots 44 & 57 west of the Kenai Spur Hwy; T 6N R 12W SECTION 23, Seward Meridian, AK; in the Salamatof Community; ESN 501	UNNAMED RD	RORRISON AVE	KR01

Section 2. That according to Kenai Peninsula Borough Code of Ordinance 14.10.030, the official street name map, 1:500 scale base map Kenai River 01 is hereby amended to reflect these changes.

Section 3. That the map showing the location of the renamed rights-of-way be attached to, and made a permanent part of this resolution.

Section 4. That this Resolution takes effect immediately upon adoption.
